Overview

The purpose of the Berkley Conservation Scholarship is to fund internships for YSE students to:

- (a) work with organizations involved in the conservation of land in the United States, and
- (b) help develop and apply new and innovative strategies for preserving open space.

Scholars are selected on the basis of superior academic performance and demonstrated interest in a career involving land conservation.

Award details

An award of up to \$9,000 will be made to each scholar. The scholars will then be free to apply the funds to an internship secured with an organization involved in private land conservation in the United States (subject to final review and approval by YSE). Please note that students who are awarded the Berkley Conservation Scholarship will not be eligible for other YSE CPD Supplemental Funds (though they may be eligible for non-CPD YSE, Yale, and external to Yale funding).

To the extent possible, each Scholar's internship work should touch on one of the three major themes of the Berkley Program:

- Engaging new communities in conservation;
- Expanding the conservation toolkit;
- Ensuring the permanence of conservation gains.

The internships should be of value to both the sponsoring organization as well as the broader land conservation community.

The normal length of an internship is 10-12 weeks between early/mid-May and the end of August.

The primary duty of the Scholars is to undertake their summer projects to the best of their abilities and to the highest professional standards.

Following the experience, Scholars will be asked to prepare at least three written products:

- (a) one summarizing the results of their work in whatever form is requested by their sponsoring organization;
- (b) a more general review of the lessons learned from their project for distribution to the broader land conservation community; and
- (c) a short assessment of their experience to be shared with the donors.
