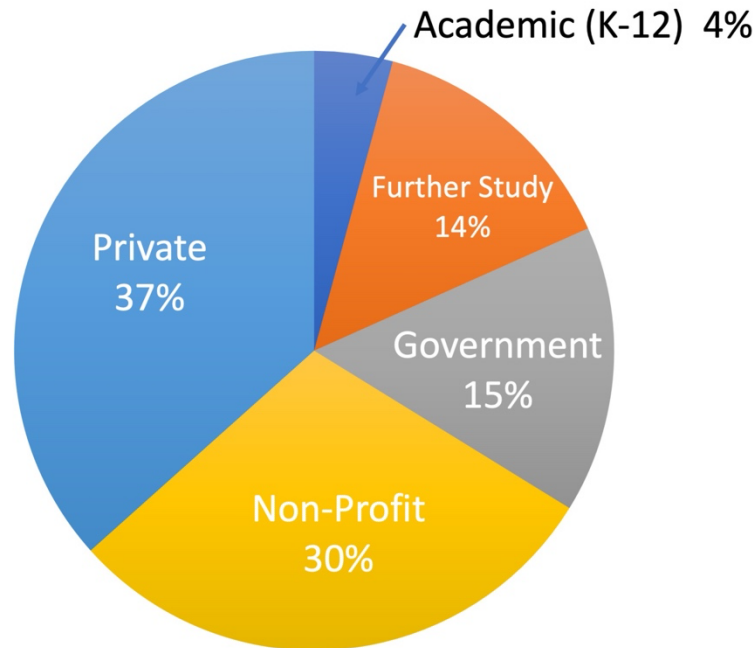


2021 Master's Degree Graduates Six Months after Graduation First Destination EMPLOYMENT BY SECTOR: 75 RESPONDENTS
