



## VISIT OVERVIEW

The 2018 Wall Street Trek was organized by the undergraduate Finance and Investment Club. More than 100 students, led by Finance Club President Majid Mowlood, traveled by bus to New York for two days of company visits, presentations, panel discussions, and alumni networking.

On Friday, students divided into four groups, each led by a Finance Club e-board member. These groups each visited 2-3 companies for additional presentations and networking opportunities.



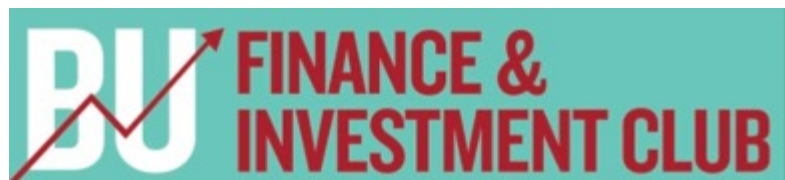
